CafeKitty kittens are sold into approved homes only. All babies are born inside our home and given individual love and attention from day one. Christina Langelier, Breeder, agrees to sell you a healthy kitten/cat in the amount of \$2500 under the following conditions: a non-refundable deposit of \$1000.00 is required. A kitten/cat sold as a pet will be spayed or neutered prior to delivery. Kittens/cats cannot be bred under this contract. Once microchipped, all documents will be placed in new owners name and cannot be changed therefore kitten/cat must be paid for in full before microchip implant, neuter and optional tattoo (payment due in full by 8 weeks of age). Payment must be made via Paypal with 3% added for Paypal fees, *Interac* Email Money Transfers (Canada only) or a Bank Money Order (Canada only – must allow 2 weeks to clear before shipping).

Buyer agrees that this kitten/cat will not be sold or given away, used for any experimental test, or abandoned. If buyer is unable able to keep the kitten/cat, CafeKitty will provide a home for it. Buyer will receive any money collected for the kitten in this instance only. Unless otherwise specified, there are no refunds of any kind. Registration form & CafeKitty pedigree will be provided as soon as blue slip is received from TICA.

This kitten/cat is guaranteed to be of sound health upon arrival. It is guaranteed for a period of 72 hours from time of purchase (arrival) if vet-checked within that time. It is recommended that the new kitten/cat be kept in quarantine during this time. If it is found to be medically deficient with an untreatable or life-threatening problem, it must be reported to the breeder immediately. Upon its return, it will be replaced with another kitten/cat of equal or greater value or the purchase price will be refunded. If no replacement is available at that time, seller will have 6 months to furnish satisfactory replacement. The cat/kitten cannot be returned after the guarantee period has expired and/or if it has been exposed to another cat which has not been currently tested for FeLV and FIV. It is the responsibility of the buyer to provide immediate veterinary care to any cat/kitten showing signs of illness or distress and failure to do so will render any guarantee null and void. Under no circumstances is a kitten to be destroyed prior to notification by the buyer to the seller. If a cat/kitten dies within the guarantee period, despite medical treatment, compensation will be made ONLY if a veterinarian certifies the cause of death.

This cat/kitten is also guaranteed against congenital defects for two years. Should the cat die within that time as a direct result of a congenital defect, the cat will be replaced ONLY if an appropriate necropsy is performed by a licensed veterinarian and a veterinary certificate is provided as proof of cause of death. A replacement will be made of a cat of comparable quality and value, as available, at the discretion of the breeder.

This contract is legally binding to all parties involved. It applies only to the buyer and seller in this transaction and is non-transferable to other parties
